# PROBENTIROX®

## Food supplement with Maritime pine extract

**INDICATIONS:** Probentirox® is a food supplement with Maritime Pine Extract, Vitamin E and Vitamin C. Maritime Pine Extract exerts antioxidant action; Vitamin E contributes to the protection of cells from oxidative stress; Vitamin C contributes to the normal function of the immune system.

**INGREDIENTS:** Capsule content: Bulking agent: Calcium phosphate dibasic, Lipoic acid, Vitamin E acetate tit. 50% (tocopheryl acetate, modified starch, emulsifier: gum arabic, sucrose), Lycopene from tomato (*Lycopersicon esculentum* Mill., Fruit) tit. 6% (contains corn starch), Maritime Pine (*Pinus pinaster* Aiton) dry bark extract tit. min. 95% in oligomeric proanthocyanidins (OPC), Vitamin C protected tit. 97.5% (ascorbic acid, coating agent: ethylcellulose), Astaxanthin complex tit. 2.5% (oleoresin from *Haematococcus pluvialis*, modified starch, antioxidants: ascorbyl palmitate, dl- $\alpha$ -tocopherol), Anti-caking agents: Magnesium salts of fatty acids, Silicon dioxide, Talc. Outer casing (can contain sulfur dioxide): Bovine gelatin, Dye: Titanium dioxide.

**DIRECTIONS FOR USE:** It is recommended to take 1 capsule with half a glass of water at bedtime. Do not exceed the recommended daily dose.

**WARNINGS:** If you are being treated with hypoglycemic agents before the possible use of the product, seek medical advice. Although there are no known interferences with drugs, it is recommended that administration is at least 1h away from treatments, possibly in the evening.
